

# Contest rules "A renewal, a world of possibilities"

#### 1. MANDATORY RULES

Subject to applicable laws, these rules govern all aspects of the contest "A renewal, a world of possibilities."

### 2. CONTEST DURATION

If the answer is incorrect or the participant is ineligible for any other reason, the prize will simply be forfeited.

### 7.1. To be declared a "confirmed winner," the participant must:
